1. The Ministerial Dialogue regarding the Social Charter of the Americas will be an *opened dialogue*. The participants will have the opportunity to express any issues regarding the main theme of the event.
2. The Venezuelan Government will issue a Press Release, informing everything related to this event. *There will not be an official declaration.*
3. The Venezuelan Government will provide accommodations, and meals starting Saturday August 27<sup>th</sup> thru Tuesday 30<sup>th</sup>, 2005. Accommodations for all the Ministers, Ambassadors Permanent Representatives to the OAS, and to the Officials of International Organizations that have been invited, will be at the Hotel Caracas Hilton
4. On Sunday August 28<sup>th</sup>, during the morning, a cultural or recreational event will take place. Information regarding this will be provided in the next few days.

The Ministers Members of the Cabinet for Social Development of Venezuela will host a luncheon, on Sunday August 28<sup>th</sup>, at 1:00 pm., in honor to the Ministers, Ambassadors Permanent Representatives to the OAS, and to the Officials of International Organizations that will attend the event.
6. The Venezuelan Government is working in order to facilitate the transportation for all the Ambassadors Permanent Representatives to the OAS, and for the Officials of International Organizations.
